REVIEW OF MINUTES:

TREASURER'S REPORT:

Treasurer, Corky Springfield, reviewed our operating budget financial status for the month ending July 31, 2009. He reported that \$27,803 was collected in pledge receipts for July of a budget of \$40,100. He stated that \$10,000 in Pre-Paid Pledges was used in July, leaving a balance of approximately \$8,000. Corky reported that we are behind budget approximately \$12,000 year-to-date. He stated that pledge statements will be sent soon. Corky reported that expenses continue to be under budget year-to-date.

In the meantime, he noted that several parishioners had asked about contributing money toward this project. Paul suggested that a restricted account be established for people who want to make a contribution toward the columbarium.

Approve funds for Wednesday night kickoff event

Paul advised the Vestry that September 16, we will kickoff our Wednesday night suppers and activities. He noted that Dr. Robert Khayat will be our special guest. Paul stated that the evening will be a very festive event with a social time prior to the meal. Cathy Fitzpatrick and her committee are organizing the details of the meal and the activities for the night to make it a gala event. Paul reported that the Stewardship Committee will be using funds from their budget, funds will be contributed from the Hospitality Committee budget and the Rector's Discretionary Fund. He asked the Vestry to approve the use of funds in the amount of \$1,991.56 from line item #8030-Money Market Interest Earned for the September 16 event.

Approve distribution of funds to Rector's Discretionary account

Paul reminded the Vestry that several months ago, Assistant Treasurer, Mary Lou Parks discovered that \$5,000 from the John Murrow estate designated for the Rector's Discretionary Fund had mistakenly been credited to line 8043-"Building Reserve, New". Paul asked the Vestry to approve the transfer of the funds to his discretionary account.

Approve the transfer of \$5,000 from line 8043-"Building Reserve, New", to the Rector's Discretionary Fund.

Advertising/Marketing of the church

A discussion was held concerning how we can best advertise/market All Saints' to the wider community. It was noted that in 2008 a commercial was made and aired on cable television for 13 weeks. It was also noted that we currently advertise in the Saturday church listing section of the Northeast Mississippi Daily Journal. After the discussion, the following motions were made:

Advertise in the Saturday Religion section, the Monday edition, the Wednesday Neighbors section and online with the Northeast Mississippi Daily Journal at a cost of \$520 per year.

APPROVED.

MOTION: (Bryan/Vance)

Authorize the rector, to create a task force to study how best to advertise and market All Saints'.
